# RULES AND REGULATIONS

1. The organizers reserve the right to cancel / withheld re-allot the stalls in case of any payment default.
2. The organizers reserve the right to change the layout/size/zone of the stalls as in part of adjustments, if necessary.
3. The allotment of stalls will be on first cum first serve basis.
4. Participation: Application for participation is to be made in the prescribed form. Acceptance of participation and exhibits will be at the sole discretion of the organizers.
5. **a). Stall Possession: Bare Space 29<sup>th</sup> May 2020 at 10.00 am. b).Shell Scheme: 30<sup>th</sup> May 2020 at 10.00 am.**
6. Electricity charges: Available at 230 Volts/1 phase and 400 Volts. 3 phase A.C 50 Cycles. Additional requirement per KW on Chargeable Basis. Additionally request for power connection should be made along with payment one month prior to the commencement of the event.
7. Vacation of space: Exhibition space will have to be vacated by 6 am on 5<sup>th</sup> June 2020 failing which participants will be required to pay penalty as prescribed by the authorities.
8. Security: The organizers will make the general security arrangement. However, Exhibitors will be responsible for the security of the exhibits at their stall.
9. Cancellation: No refund of advance paid will be made after signing the space application form and advance payment received. Any cancellation on or after March 2020 will attract complete payment of the participation charges due. In case of non-compliance, legal action will be initiated.
10. **PAYMENT SCHEDULE: Advance payment at the time of Booking - 10%, Second Installment before April 2019 - 30%  
Third Instalment by December 2019 - 30%, Final Payment by March 2020 - 30%**
11. Handling of Exhibit, Customs and Import: Services for handling, Clearing and forwarding would be available at the Exhibition Ground at Extra Cost.
12. Display of Banners / placards, high volume of sound with speakers which interfere with other exhibitors in the premises is not permitted.
13. Sale of Exhibit: Sales are not allowed during the Exhibition. However negotiations for sale may be conducted. For any sales at the Exhibition, Exhibitors have to ensure that the concerned authorities are informed in advance and all payable taxes are deposited by the exhibitors. The organizers will not be responsible in any way for any violations by the Exhibitor.
14. Force Majeure : If the Exhibition is abandoned, cancelled or suspended in whole or in part by reason of war, fire, natural calamity, national emergency, labor dispute, the non-availability of exhibition Premises or any other cause not within the control of the Organiser, Under these circumstances, the Organiser may, at their entire discretion, repay the Participation Expenses paid by the Exhibitor or Part thereof but shall be under no liability in respect of any actions, claims or losses.
15. Insurance : Against all ascertainable risks from transportation to display and removal should be done by the Exhibitors at their own cost. Organiser will in no way be responsible for this. Exhibitors will insure their Exhibits against loss, damage, theft, fire etc. The Exhibitor will also ensure third party insurance for the total duration of the Exhibition.
16. The Exhibitor shall not use the space behind the stall or between the stalls for storage or for any purpose what so ever.
17. The stall allotted will not be transferable and shall be used only by the allottee.
18. Furnishing shall be completed and all material not for use in the stall shall be removed before 6 am on 1<sup>st</sup> June 2020.
